In view of the prevailing disturbed situation wherein public transport is not operating properly and government offices are not functioning and due to the requests from general public, it is decided to extend the last date for the receipt of ONLINE application for both the HOUSING UNITS in Rushikonda and PLOTs in VUDA developed layouts till 30<sup>th</sup> September, 2013.

The allottees are requested to note the changed schedule as follows:

- Last date of application for Row Housing Flats and Vacant Plots : 30<sup>th</sup> September 2013
- Date of auction of Row Housing Units: 5<sup>th</sup> October 2013
- Date of auction of Plots: 11<sup>th</sup> and 12<sup>th</sup> October 2013

DETAILS OF CHANGES IN THE COST OF APPLICATION ( if applied for more than 10 units/flats/plots)

Due to written requests from people, wherein people who have opted for more plots/flats, that they have to spend Rs.500/- for each application, requested to reduce the cost of application in such cases. The matter was discussed with the HODs on 28.08.2013 and also with the Principal Secretary, MA&UD Department and the Chairman, VUDA and decided that application fee of Rs.500/- for each online application applies upto 10 applications. If an individual is bidding for more than 10 plots/flats/units, the applicant has to pay for each plot/flat after the 10 applications at a cost of Rs.250 per application ( For example, if an allottee wants to apply for 15 plots, then he/she has to pay  $(10 \times 500) + (5 \times 250) = \text{Rs. } 5000 + \text{Rs. } 1250 = \text{Rs. } 6,250$ )
