**ORDER:**

The applicant Sri Srinivasa Venkata Babu, M/s. Terracon Projects Visakhapatnam have developed the layout as per the specifications of VUDA to the letter in the reference 1<sup>st</sup> cited and also handed over the roads and open spaces etc., to the Panchayat Secretary, Sabbavaram Gram Panchayat vide Regd Gift Deed No: 2201/2012, dated: 06-6-2012 of Sub-Registrar, Sabbavaram. Further, the plots mortgaged to VUDA vide Document No: 7398/2007, dated: 17-12-2007 have been released vide Deed of Reconveyance No: 2257/2013, dated: 15-7-2013 of Sub-Registrar, Sabbavaram.

In view of the above, the Final Layout LP.No: 81/2007 is hereby released subject to the following conditions:

1. Every Building site shown in the sanctioned L.P No. 81/2007, dated: 20-12-2007 shall be utilized for the construction of only dwelling house and no shop godown / industry or any other building which are not ordinarily connected with dwelling shall be constructed in the site. No Building shall be converted to any use other than for which it has been permitted for.
2. The every plot holder shall obtain prior approval of building plans from the competent authority as per the rules in force.
3. This layout has been provided with water supply, sewerage and drainage disposal system street lighting, rain water harvesting structures, parks / open spaces, avenue plantation and other civic amenities, the local body shall ensure proper and effective maintenance of the said services and impose any further conditions for their usage and maintenance.

In view of the above, the Plot Nos: 1 to 47 & 144 to 167 (**Total 71 Plots**) which are under mortgaged to VUDA vide registered agreement & deed of Mortgage No: 7398/2007, dated: 17-12-2007 are hereby released by VUDA, vide registered deed of Reconveyance of mortgage Deed No: 2257/2013, dated: 15-7-2013.

Two sets of Layout plans L.P.No.81/2007 are herewith enclosed. The Panchayat Secretary, Sabbavaram Gram Panchayat is requested to release one set of Plan to the applicant and direct the applicant to strictly adhere to the conditions. Any deviation in this matter will be viewed seriously and action will be taken as per the provisions of the Act.
